Of course, we could not have achieved this shift without Dr. Nila Das, our dedicated Executive Director, and our empathetic staff advocates. Having a strong team on the front line makes the world of difference to our children/youth, along with their families, during one of the most traumatic times in all of their lives. Additionally, the strong relationships and partnerships that we have with our key stakeholders allows for conversation, brainstorming, and growth. We are so fortunate.

I would like to thank the Department of Justice for their continued financial support; we would not be this thriving organization without their funding. While we have work to do in the future to secure stable funding and not rely solely on yearly grants, we are so appreciative of the organizations in the Windsor/Essex who donated funds to the Centre so that we can continue to do the work that we do so well.

Executive Director's Message

Dear Friends and Supporters,

As the Executive Director of the Windsor Essex Child/Youth Advocacy Centre (WECYAC), I am proud to share the strides our team have made over the past year in our mission to support and advocate for child and youth victims of crime and abuse.

This fiscal year, we commemorated Victims Week by celebrating survivors and the dedicated professionals working alongside them. We organized brainstorming sessions with partners from 31 local organizations, bringing together 73 professionals. This event facilitated a vibrant exchange of ideas, resulting in valuable insights and actionable initiatives.

Our efforts to enhance public awareness and education have also seen great success. We partnered with the Windsor Essex Counter Exploitation Network to raise awareness about human trafficking and joined forces with the Violence Against Women Coordinating Committee to educate our community. These efforts led to significant outcomes, including changes to residence training, the incorporation of a module on intimate partner violence in mandatory training, and St. Clair College's inclusion in the Violence Against Women Coordinating Committee of Windsor Essex. Additionally, resources on parenting norms and intimate partner relationships, including relevant laws, will be made available on the college's website.

Furthermore, we partnered with HEART STRINGS Trauma Education and Healing Arts Studio, where children and families receive unlimited healing support sessions through dance, art, and music.

We are also grateful for the partnership and generous contributions from the Quilters Guild of Windsor, who donated quilts to every WECYAC child and youth, furthering their support and partnership.

Looking ahead, we remain committed to advancing our services for our community's children, ensuring our employees' well-being, and expanding our reach. We have implemented significant changes in our policies to offer a hybrid work environment. All employees will receive medical, dental, and life insurance benefits, as well as access to an Employee Assistance Program (EAP).

We are excited to continue our innovative programs in collaboration with St. Clair College and other community partners. The development of our new mentorship model with St. Clair College is aimed at fostering trust and healing through meaningful connections between young adult mentors and the children we serve.

We will also work on enhancing our public awareness campaigns. Continuing our partnerships with the Windsor Essex Counter Exploitation Network, we plan to work closely with survivors to create an awareness campaign targeting youth.

We deeply appreciate the unwavering support from our partners, donors, and volunteers. Your contributions have been instrumental in helping us achieve our goals and expand our reach.


The CYAC model promotes targeted community awareness by implementing comprehensive communication strategies aimed at educating the public about child abuse and exploitation




